

# Terms and Conditions for the EdForAll Bursary Programme

## Introduction

These Terms and Conditions govern the EdForAll Bursary Programme (Bursary Programme) offered by EdForAll in partnership with Regenesys Business School (Regenesys). By applying for this bursary, you agree to be bound by these Terms and Conditions. Please read them carefully before submitting your application.

## Eligibility Criteria

To be eligible for the EdForAll Bursary, applicants must meet the following criteria:

- **Age:** Must be between 18 and 35 years old at the time of application.
- **Academic Standing:** Must be a current second-year or third-year student in good academic standing at a recognised higher education institution.
- **Income Threshold:** Must have a household income of less than R600,000 per annum. This threshold increases to R850,000 per annum for applicants with a registered disability.
- **Residency:** Must be a South African citizen or hold permanent residency in South Africa with a valid SA ID number.
- **Programme Enrolment:** This bursary is only for the following programmes
  - Bachelor of Public Administration
  - Bachelor of Business Administration
  - Higher Certificate in Business Management
  - Higher Certificate in Public Management

## 3. Application Process

- **Submission:** Applications must be submitted through the official EdForAll website using the provided form. Incomplete or late applications will not be considered.
- **Documentation:** Applicants must provide all requested documentation, including proof of income, academic records, and a copy of a valid SA ID. Failure to provide all necessary documentation may result in disqualification.
- **Deadlines:** Application deadlines are strictly enforced. Applicants are responsible for ensuring that their applications and all supporting documents are submitted by the deadline date provided on the EdForAll website.

## 4. Selection Process

- **Review:** All applications will be reviewed by a selection committee comprised of representatives from EdForAll and Regenesys. The committee will assess applications based on the eligibility criteria and the quality of the submitted materials.
- **Notification:** Successful applicants will be notified via email or telephone. All decisions by the selection committee are final, and no correspondence will be entered into regarding the outcome of applications.

## 5. Bursary Award

- **Coverage:** The bursary covers tuition fees for the recipient's second-year or third-year studies.
- **Disbursement:** Bursary funds will be disbursed directly to Regenesys on behalf of the student. No funds will be transferred directly to recipients.
- **Conditions:** Recipients are required to maintain a minimum GPA as specified by Regenesys and must not be subject to any disciplinary actions.
- **Continuation:** Continuation of the bursary into the third year is contingent upon the recipient maintaining satisfactory academic performance and adherence to all terms and conditions.

## 6. Obligations of Bursary Recipients

- **Progress Reports:** Bursary recipients are required to submit academic progress reports at the end of each semester. Failure to submit these reports may result in suspension or termination of the bursary.
- **Engagement:** Recipients may be required to participate in promotional activities related to the Bursary Programme, such as testimonials, interviews, or photo sessions. Participation in such activities is voluntary but encouraged as part of the community engagement aspect of the bursary.

## 7. Termination of Bursary

**Grounds for Termination:** The bursary may be terminated if the recipient:

- Fails to maintain the required GPA as outlined by Regenesys.
- Is found guilty of academic dishonesty or misconduct.
- Does not comply with the reporting requirements or fails to engage cooperatively with the programme's administrative requirements.
- Experiences changes in eligibility status, such as no longer meeting the income criteria or discontinuing studies.

**Notice of Termination:** In the event of termination, recipients will be notified in writing with an explanation of the reasons for termination. Recipients will have the opportunity to appeal the decision within a specified timeframe.

## 8. Appeals Process

- **Procedure:** Recipients may appeal any decision regarding their bursary status by submitting a written appeal to the Bursary Programme Appeals Committee within 30 days of notification.
- **Committee Review:** The Appeals Committee will review the appeal and make a decision based on the available evidence. All decisions by the Appeals Committee are final.
- **Communication:** The outcome of the appeal will be communicated to the appellant in writing within 30 days of the appeal submission.

## 9. Privacy and Data Protection

- **Confidentiality:** All personal information provided during the application process will be treated with confidentiality and in accordance with applicable privacy laws.
- **Use of Information:** Personal information will only be used for the purposes of administering the Bursary Programme, including assessing eligibility, processing applications, and managing the bursary awards. Information may also be used for promotional purposes associated with the bursary programme, subject to the consent of the recipients.
- **Data Security:** EdForAll and Regenesys are committed to protecting the security and integrity of personal information through appropriate technical and organisational measures.

## 10. Amendments to Terms and Conditions

- **Notification of Changes:** EdForAll reserves the right to amend these Terms and Conditions at any time. Any changes will be effective immediately upon posting the revised version on our website. It is the applicant's responsibility to stay informed of any changes.
- **Acceptance of Changes:** Continued participation in the Bursary Programme after changes to the Terms and Conditions have been made will constitute acceptance of the revised terms.

## 11. Governing Law

- **Jurisdiction:** These Terms and Conditions shall be governed by and construed in accordance with the laws of South Africa.
- **Dispute Resolution:** Any disputes arising out of or related to the Terms and Conditions or the Bursary Programme shall be resolved through mediation or, failing that, by arbitration in accordance with the Arbitration Foundation of Southern Africa.

## 12. Miscellaneous

- **Non-Transferability:** The bursary is not transferable and is awarded to the individual applicant only based on the eligibility criteria and selection process outlined herein.
- **No Employment Relationship:** Receipt of the bursary does not constitute an employment relationship between the recipient and either EdForAll or Regenesys.
- **Commitment to Fairness:** EdForAll and Regenesys are committed to fairness, transparency, and equality in administering this Bursary Programme. No applicant or recipient shall be discriminated against on the basis of race, colour, gender, religion, national origin, disability, or any other protected status.
